

Pension fund attains overall network security.

## **THE COMPANY**

A pension fund for major metropolitan police and fire departments collects contributions from employees who are working and disperses pension payments to retirees. This fund manages accounts for more than 5,000 employees and a similar number of retirees.

That adds up to more than 10,000 people whose personal information, including salary and pension information, is stored on the pension fund's systems. To provide the best service for its members, the fund has a modern data network and an interactive website. But the organization consists of a small twoperson IT team with neither having the sole focus or expertise around security.
